# Program Schedule\*

## September 8-9, 2016

You can find further information below about the event. We would also be delighted to offer a customized range of activities to suit your interests, so let us know if you would like to include any specific activities and we will do our best to accommodate them.

### September 8

After welcoming you to the Program with morning coffee, you will then start your first day with a chance to meet one of our leading faculty members at a morning lecture. They will lead you through some of the projects they are currently working on and will give you an insight into life in their area of the University.

You will then explore the Byre Theatre, now run by the University, with a backstage tour, followed by a private performance. You will be served a delicious lunch at the Byre Bistro where you will have the opportunity to meet with some of our faculty members.

After lunch, you will be welcomed to the newly redeveloped Sports Centre by the Director of Sport and Exercise and his team where you can view all the upgraded sports facilities (including the new flagship Sports Arena), meet the students who use the enhanced facilities and hear about our vision for sport at St Andrews.

Later in the afternoon you'll be invited to learn more about the teaching and research taking place in our School of Medicine as you

tour the cutting-edge facilities of the Medical and Biological Sciences building and then attend a lecture there.

In the evening you are invited to dine at Balcarres House as the guests of University supporters Lord and Lady Balniel. You will also be given a private viewing of some of their vast collection of stunning works of art and will have the opportunity to meet with more of our academic staff who will join the group.



### September 9

The Gatty Marine Centre, located on the East Sands, is a hub for marine biologists and those seeking to maintain and improve the health of our oceans for future generations. In the morning, you will visit the Centre where you will learn more about the groundbreaking research taking place there. You are also invited to take a short boat trip around the beautiful coastline surrounding St Andrews to view some of the rich and varied wildlife living there.

You are then invited to an informal lunch, held at one of the University's main historic venues, where you'll have time to chat about the morning's activities over a buffet-lunch.

Following lunch one of our leading faculty members will welcome you to an afternoon lecture to hear more about their area of research.

In the afternoon you will be given a warm welcome at Martyrs Kirk. This former church has recently been transformed into a Postgraduate Reading Room and Research Library. Here, you can take the opportunity to examine and learn about some of the precious items in our Special Collections, selected for you by our team of experts who work hard to catalogue and preserve them for future generations.

You are invited to dine that evening as a private guest at Kemback House, a stunning property just outside St Andrews. Musical entertainment will bring the evening to a close.
